To continue our progress towards achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 45.6 tCO₂e by 2026. This is a reduction of 17.24%

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2021 baseline. The carbon emission reduction achieved by these schemes equate to **4.02** tCO₂e, a **7.29**% reduction against the 2021 baseline and the measures will be in effect when performing the contract.

- Celerity implemented an electric car scheme for its employees, this is open to any employee wishing to purchase an electric car.
- A hybrid working model has been introduced for all staff, reducing the amount of commuting to the office and the use of electricity for lighting and heating.
- Staff attend meetings via video rather than in person where possible and are selective with which events benefit from them attending 'in person'.

In the future we hope to implement further measures such as:

- Replace fluorescent lighting with LED alternatives where practicable.
- The implementation of an ESG Policy to help focus on additional options to improve the company's environmental efforts.
